

Washington Bus Trip

The Cape May County Historical and Genealogical Society is sponsoring a chartered bus trip to Washington, D.C. on Saturday, April 18 and Sunday, April 19, 2009. This is a two-day trip with overnight accommodations at a Comfort Inn in the area. Included with the cost of \$150.00 per person is transportation, hotel room based on double-occupancy (a single room can be arranged for an additional fee), snacks, driver tip, however meals are on your own. The hotel does provide a Continental breakfast.

Now, here is our itinerary:

On Saturday a guided tour of Abraham Lincoln's summer Cottage located on the grounds of the Soldiers Home and a guided tour of Woodrow Wilson's house, the only museum dedicated to a President in Washington. Both of these tours have been secured and admissions to both sites are minimal and at a group rate. If you are a member of the National Trust for Historic Preservation, your admission to both these sites is free; however you must present your membership card upon entering.



On Sunday, the day is free to explore the many Smithsonian Institution buildings; the Museum of American History which has just reopened after a two-year renovation contains the restored Star spangled Banner (War of 1812), First Ladies Inaugural Gowns, Julia Child's kitchen and so much more. Special Lincoln exhibits are being shown at the National portrait gallery and elsewhere to commemorate the Lincoln Bicentennial year of his birth. There are lots to see and do along the Mall – a map of that area will be provided.



LOST: The early 1700's Kruk house in Seaville has recently been demolished for future development of the site. Sharon Kruk, daughter of former Upper Township mayor, Frank Kruk, donated the stone mile marker that now resides in the Gandy Farmstead barn.

The mile marker originally stood across Shore Road from the Kruk residence. It was acquired by the family sometime in the 1940's and mortared into the brickwork above the fire place. At the time of Sharon's generous donation, the marker was laboriously removed from its location by a team of volunteers, namely Lewis Albrect, James P. Hand, and Les Worrell. This heavyweight historical object is placed for outdoor exhibit during the AppleFest. Be sure to look for it!

Architectural Committee Report

UPDATE ON BUDGET FUNDS: \$12,500.00 that we had been counting on has been taken from us by the Upper Township Committee.

Seaville Historic District: It appears that the Committee is wary of the Seaville Historic District project. \$5000.00 of the previously approved funds for the district and included in the 2009 budget has now been tentatively denied by the Committee. We saved \$2000.00 by bartering donated shutters that we were unable to use at the Farmstead, to a painter to do some painting on the Farmstead buildings. We were originally told that the \$2000.00 saved could be applied to the Historic District project. This money was also taken back by the Township. A request to combine budgeted funds was also denied. Carol and architectural historian, Joan Berkey, will continue to pursue plans for the proposed Seaville Historic District, possibly using HPS funds.

Train Station: Progress on the Speeder Building seems to be stalled. Approximately \$5500.00 of the money which had been dedicated for work on the Speeder Building in the 2007-2008 budgets has also been taken back. Carol was told at a budget meeting that encumbered money not spent was lost. Paul Dietrich suggested to the committee that quite a bit of work was done by Steve Martinelli and Doug Longenecker to further the project, so there is a possibility that the building still could be constructed maybe by using Township employees.

FARMSTEAD: Window sash on the house is in dire need of putty and paint. Dan Clark will contact friend of the society, Ed Pearce, who has donated material and labor to paint several Farmstead buildings in the past. Marj and Bix are pruning the grapevines. Someone is needed to take on the fruit tree spraying. Due to health problems, I can no longer do this. The trees should be sprayed once every ten days during the growing season, from April to July. If a volunteer is not forthcoming, spraying will have to be paid for with Society funds.

FRIENDSHIP SCHOOL: Carol reports that the rotting steps at the school have been replaced.


